Prairie Christian Academy is operated by Prairie Christian Academy Society, in conjunction with Golden Hills School District, as an alternative Protestant Christian School. Therefore, membership in the Society shall be limited to Protestant Christian believers who express agreement with the Statement of Faith as outlined in the Society's bylaws, who support the Objects of the Society, whose application for admission as a member has received approval of the Board of Directors of the Society and who are Parents of Students who are duly enrolled in the Society's School and whose enrollment fees are not in arrears.

Membership fees and dues shall be as directed by the Board of Directors, and subject to annual renewal.

Any member may withdraw from the Society by delivering to the Society a written resignation and lodging a copy of the same with the secretary of the Society.

Members of the Society shall remain in good standing for as long as they wish to retain membership and they continue to meet the eligibility requirements.

A membership in the Society is not transferable.

A member has the following rights and privileges:

1. Any member in good standing has the right to vote at any meeting of the Society, in person, not by proxy.
2. Any members may be expelled for any cause which the Society may deem reasonable upon a three-fourths vote of all members in good standing present at a properly called meeting of the Society.
3. Any member in good standing may accept nomination for elected position in the Society.
4. Membership of parents or guardians does not guarantee admission of children to PCA.
5. Any member of the Society may inspect the register of members at the Society office.
6. Any member of the Society may request copies of the bylaws, registrar of members or audited financial statements of the Society.
7. Any member of the Society may, on giving reasonable notice, inspect the financial records of the Society.
8. No member of the Society is, in his individual capacity, liable for a debt or liability of the Society.
